Pezzano Mickey Law, LLC will now be known as "Pezzano Law Group," effective immediately.

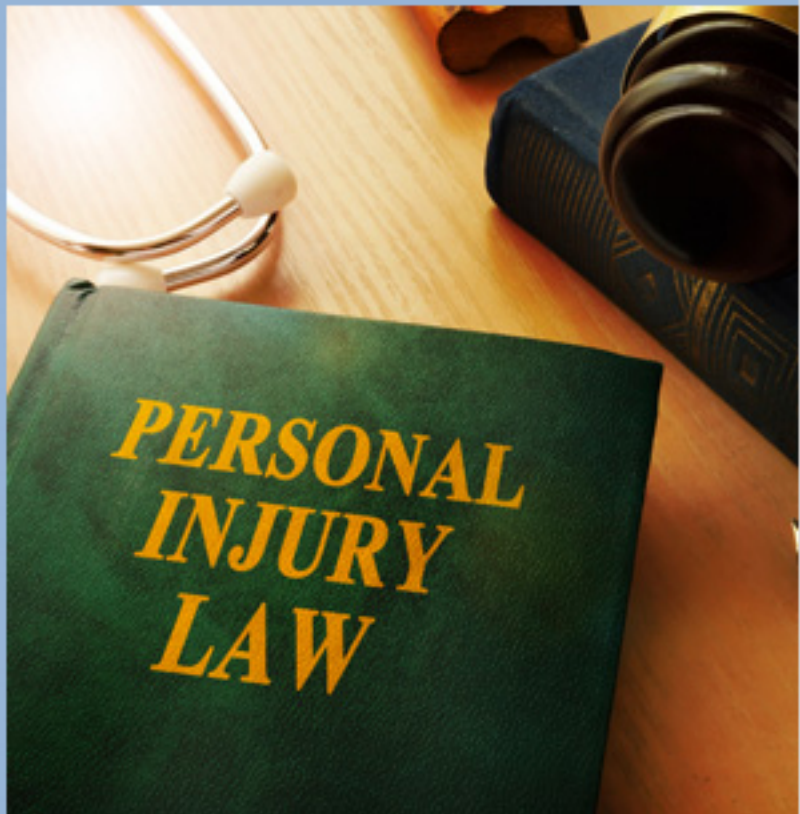
